NHCS Pretest

- All data elements subject to modification based on pretest results
 - Clarity
 - Response rate/distribution
 - Efficiency of skip pattern
 - Completeness of ED chart
 - Reporters feedback
- Modifications ready for 2013 launch



#1 DAWN Data Elements Will Carry Over

- Most DAWN elements carry over
 - Same definition of "drug-related visit"
 - All substances involved captured:
 Rx, OTC, supplements, illicit. DRV-based, up to 16
 - Alcohol
 - <21 alone & in combination; >= 21 alcohol with other
 substances
 - Demographics, disposition, length of ED stay, etc.
- DAWN "case types" Approach modified



#2 New Elements

- "New" elements
 - Some added by SAMHSA
 - Others are NHCS elements
 - All add richness to drug related ED visits data
- Three categories
 - Substances
 - Mental health
 - Health services



New Elements: Substances

- For each substance, did the patient take:
 - Own pharmaceutical (i.e. Rx, OTC, or supplement)
 - Another's pharmaceutical
 - According to directions
 - Took too much(Record all that apply)
- BAC (Blood Alcohol Level)



New Elements: Mental Health (a)

- Intentional injury, poisoning, overdose:
 - Added suicide gesture/ other self harm(e.g. cutting) in addition to actual attempt
- Suicidal ideation
- Co-occurring mental conditions
 - Bipolar, depression, schizophrenia
- Co-occurring physical conditions
 - _CVD, hypertension, dementia, diabetes, cancer



New Elements: Mental Health (b)

Providers

- Psychiatrist, psychologist, social worker or other
 MH provider
- Procedures
 - Psychiatry/psychology/substance consult
- Transfer and referral status
 - Identifies psychiatric inpatient (voluntary or involuntary,) and substance abuse treatment



New Elements: Mental Health (c)

- More thorough capture of all diagnostic codes
 - ICD codes
 - Up to 20 diagnoses
 - Substance abuse, misuse, dependence
 - Mental disorders
 - Co-occurring physical disorders
 - _ Accidents, injuries



New Elements: Health Services

- Source of payment/type of Insurance
- Usual residence
- Episode of care
- Prior visit < = 72 hours ("revolving door")
- Medications given during visit or Rx at discharge



#3 Expanded Opportunities for Research and Surveillance

- Ability to relate substance visits to data previously not available:
 - Clinical data, e.g. concurrent mental & physical
 - Facility characteristics
 - Follow patients admitted to same hospital; link with Medicare claims and National Death Index
 - Payers/claims data, uninsured
 - "Revolving door" SA/MH patients
 - And much more!
